

Note 2: the footwear also meets the requirement in accordance with IEC 61340-5-1:2016 (IEC 61340-4-3:2017) for the electrical resistance ESD (electric dissipative footwear). on a stitched label and displaying the following information: Marking: CE Marking; - registered trademark, name and complete address of the Manufacturer; - designation of the footwear (= article name and alphanumeric code); - nr. and year of the Standard of reference + safety symbols; - size of the footwear (printed on the outsole); - production date (month + year);
